The idea was to fulfil certain standards of legal education, but more importantly, it was also aimed at engaging the students in serving their community by promoting legal awareness through these legal aid clinics and programs. We, the Kerala Law Academy has successfully established the Legal Aid Clinic at our institution since 1973.

Legal aid is the vehicle through which the constitutional pledges are fulfilled in both letter and spirit, and equal justice is made available to people who are most vulnerable, deprived and marginalized

We believe that involving law students in assisting the poor and vulnerable serves a dual purpose of sensitizing the young minds to the legal needs of poor people as well as disseminating legal knowledge on rights and entitlements in the communities. The Legal Aid Clinic & services at KLA aims to raise legal awareness and education in the society It provides legal education and services to people living at the vicinity of campus, with limited access to legal protection due to their poor economic status or susceptibility to discrimination.

As a part of Legal Aid Clinic, the Kerala Law Academy in association with the National Service Scheme is all set to conduct One Week Trainer's Training Program "LAWOJ 2021" (LAW ACADEMY WINGS OF JUSTICE). And it will be held from October 20, 2021. The sole intention in organising this Legal awareness programme is that it will serve as an induction to budding lawyers and will equip them to succour the society by providing legal awareness.

### **KLA LEGAL AID CLINIC AND SERVICES**

In an effort to foster social progress, the Government of India has repeatedly emphasized the importance of Legal Aid and Awareness Campaigns. As a means towards achieving 'Social, Economic and Political Justice, legal aid is crucial for the attainment of the ideals enshrined in our constitution and under the Directive Principles of State Policy. Access to justice can be ensured more effectively and efficiently by making people aware of the legal system. Accordingly, the Bar Council of India directed all law schools and universities in India to launch legal aid clinics. In addition to fulfilling educational standards, it was also intended to engage students in service to societies. These clinics and programs promote legal awareness in society.

Legal aid clinics in law colleges marked a new era in legal education. Practice-based legal education opens broader access to the legal profession and enables the development of skills required for the profession. The students' real-life experiences provide them with the chance to develop critical thinking skills and analytical skills.

Since 1973, Legal Aid Clinics were working successfully at Kerala Law Academy. At KLA, we offer Legal Aid Clinic and Legal Services to raise awareness and educate society on legal issues. We offer services and education to individuals living nearby campus who lack access to legal protection due to their lack of resources or vulnerability. "Wings for Justice" is our motto. We make the students foremost in the legal profession as well as equip them to open helping hands to society by providing legal awareness.

We are organising one week legal awareness programme "LAWOJ 2021" (LAW ACADEMY WINGS OF JUSTICE) with the intention of training the young lawyers for providing legal awareness to the society in future. And it will be held from October 20, 2021.
